#### 2.1.2 No Keyboard Trap

If keyboard focus can be moved to a component of the page using a keyboard interface, then focus can be moved away from that component using only a keyboard interface, and, if it requires more than unmodified arrow or tab keys or other standard exit methods, the user is advised of the method for moving focus away.

#### Partially Supports

The product supports keyboard navigation but in some situation the mouse must be used

#### 2.1.4 Character Key Shortcuts

If a keyboard shortcut is implemented in content using only letter (including upper- and lowercase letters), punctuation, number, or symbol characters, then either the keyboard shortcut is only active when that component has focus or a mechanism is available to turn the shortcut off or to remap the shortcut to use one or more nonprintable keyboard characters (e.g. Ctrl, Alt, etc).

#### Partially Supports

The product support creating shortcuts using a combination of non-printable keyboard characters (e.g. Ctrl, Alt, Shift), and an uppercase letter. The user has the option to turn the shortcut off. Implementation of shortcuts for some features are missing

### 2.2.1 Timing Adjustable

For each time limit that is set by the content, the user is able to turn off, adjust, or extend the time limit, except with some specific exceptions (see link).

The product is not time dependent. The product does not include time limits

### 1.4.3 Contrast (Minimum)

The visual presentation of text and images of text has a contrast ratio of at least 4.5:1, except in some limited situations (see link).

#### **Supports**

The visual presentation (background) of text for all options/elements in product provides sufficient contrast.

#### 1.4.4 Resize text

Except for captions and images of text, text can be resized without assistive technology up to 200 percent without loss of content or functionality.

Partially Supports Some text / labels in the product can inherit text resize from a host. but the text / labels can have difficulty in displaying

#### 1.4.5 Images of Text

If the technologies being used can achieve the visual presentation, text is used to convey information rather than images of text except when the image of text can be visually customized to the user's requirements or a particular presentation of text is essential to the information being conveyed.

### 1.4.13 Content on Hover or Focus (2.1 only)

Where receiving and then removing pointer hover or keyboard focus triggers additional content to become visible/hidden, a mechanism is available to dismiss the additional content without moving pointer hover or keyboard focus; if pointer hover can trigger the additional content, then the pointer can be moved over the additional content without the additional content disappearing; and the additional content remains visible until the hover or focus trigger is removed, the user dismisses it, or its information is no longer valid (see link).

information for the most options/buttons when hover on them. Positioning the hovered content in an area that doesn't obstruct any on the screen including the hover trigger, but a hovered element has a time-limit to how long it is open and if an item is hovered over for long enough, this element will disappear.

#### 2.4.5 Multiple Ways

#### 2.4.6 Headings and Labels

Headings and labels describe topic or purpose.

#### **Supports**

Headings and labels are clear and descriptive, so specific components can be easily identified within the content.

#### 2.4.7 Focus Visible

Any keyboard operable user interface has a mode of operation where the keyboard focus indicator is visible.

Partially Supports The product uses visual changes to elements to indicate the current position of focus. In some cases a indication of the current position my not be visible.



#### 3.1.2 Language of Parts

The human language of each passage or phrase in the content can be programmatically determined except for proper names, technical terms, words of indeterminate language, and words or phrases that have become part of the vernacular of the immediately surrounding text.

Does Not Support There is no mechanism to specify different languages for subsets of a form. Content is only presented in one language - English

#### 3.2.3 Consistent Navigation

Navigational mechanisms that are repeated on multiple Web pages within a set of Web pages occur in the same relative order each time they are repeated, unless a change is initiated by the user.

#### 4.1.3 Status Messages (2.1 only)

In content implemented using markup languages, status messages can be programmatically determined through role or properties such that they can be presented to the user by assistive technologies without receiving focus.
