EFFECTIVE ONBOARDING AND OFFBOARDING PRACTICES ARE CRITICAL TO EMPLOYEE RETENTION AND PRODUCTIVITY

Engaging new hires with the particulars of their roles and familiarizing them with company culture is essential to retaining them over the long term, as well as helping them succeed in their positions at an organization. A rapid settling-in period will ensure a quicker path to full productivity, while a poor onboarding experience can result in up to four percent of new employees leaving their new job on the first day, according to a study from Bersin by Deloitte. In fact, the UrbanBound Blog reports that as much as 20 percent of staff turnover





occurs in the first 45 days of employment and pegs the cost of replacing an average employee at US\$3,000—\$18,000 (and even more for higher positions). Proper offboarding is also important: When employees leave the company, the organization must ensure that they complete the right exit interviews and that their access to company IT resources is revoked promptly.

Effective user management is critical

IT IS RESPONSIBLE FOR ENABLING USER PRODUCTIVITY WHILE MAINTAINING SECURITY.

Traditional business processes and IT are now so intertwined that the role of the IT administrator has evolved beyond the simple maintenance of servers and networks. In particular, the process of onboarding and offboarding employees now relies on technology to such a degree that your IT department has almost as big a role to play in how a new recruit settles into a job as the HR team does.

While HR will get employees onto payroll and introduce them to the company's culture, it is up to the IT department to enable new users to become productive as quickly as possible — providing them with the accounts and licenses they need to get their work done, the right storage quotas, the proper permissions to content and sites, and access to email, Teams, Skype for Business and more. At the same, IT must ensure that no one gets more access than they need; otherwise they increase the risk of security breaches and compliance failures, and pay for licenses that are not needed.

Effective user management is critical to maintaining security, enabling user productivity and controlling costs.

IT's job does not end there. As employees change roles within the organization, IT must update their access permissions to match their new responsibilities, ensuring that all user accounts adhere to the least-privilege principle throughout each employee's tenure at the organization. Finally, when an employee leaves, IT must disable or delete their accounts promptly.





The path forward

WHY IT TEAMS STRUGGLE WITH ONBOARDING AND OFFBOARDING

Busy IT departments can easily be overwhelmed by the number of users, the amount of data and the speed of change in a cloud or hybrid environment, especially if they rely solely on native tools and manual processes. Specific challenges in effectively managing Office 365 and OneDrive for Business users using native tools include:

- · Having to master multiple disparate processes
- Becoming bogged down with PowerShell commands and Excel lists, rather than focusing on good governance
- Trying to make the best use of the licenses and tools available for users
- Struggling to accurately monitor user adoption
- Not being able to rigorously enforce the least-privilege principle

workflows Having robust, repeatable and consistent processes for creating accounts, assigning licenses, granting and revoking permissions, and decommissioning unneeded accounts will help you improve both employee and IT productivity, enhance security, and control costs.

For example, the onboarding process should begin well before the employee's first day. With the official job offer email, attach a form that will collect the new hire's basic information in a format that can be imported automatically into the company's system; this workflow will enable IT to automate some of the user account provisioning work.

Ensuring licenses are used efficiently


THE CHALLENGE

Office 365 and OneDrive for Business are licensed through a subscription plan based on the number of users each month. You need to pay for only what you use — for instance, if you have 100 users, you need to pay for only 100 licenses per month. However, it's up to you to track those licenses. When an employee is hired, your IT team must ensure that the appropriate licenses are provisioned to the new user account in a timely manner. In particular, you'll want to establish processes that ensure:

- IT has all the information they need on each user, including what
 groups and level of access the user requires and whether they need
 to use special products such as Yammer or Delve.
- There are the right number of licenses of the correct type available.
- Users are added to Active Directory efficiently.
- Users get a timely welcome email with their login credentials and information on how to get help on day one.
- Training and support mechanisms are in place to educate new users on best or business practices, such as password policies.

The larger your organization, the trickier it can be to keep track of active and unused licenses, and the more money you might waste.





Of course, user and license management tasks don't end there. As employees shift roles within the organization, their license needs might change and you must update them accordingly. And when an employee leaves the company, unless you act, you'll continue to pay for their license every month even though it's not being used. If someone is hired to replace the outgoing employee, you might need to reassign the license; if not, you might want to cancel the license. Moreover, you need to ensure that the data the user owns in Office 365 and OneDrive for Business is correctly reassigned, archived or removed.

The larger your organization, the trickier it can be to keep track of active and unused licenses, and the more money you might waste. Therefore, organizations need accurate, automated ways to monitor Office 365 license usage across the business and discover licenses that have been purchased but are not being used.
